

BOOK AT BALDINI'S MOBILE SPORTS APP BONUS PROMOTION RULES
NOV 1, 2019 – JUN 30, 2020

1. To be eligible for the Book at Baldini's Mobile Sports App Bonus Promotion, a new Mobile Sports account must be opened between November 1, 2019 and June 30, 2020 in Nevada and make a minimum initial deposit of \$20 when registering their new Baldini's Casino Nevada Mobile Sports account.
2. The bonus amount will be 20% of the initial deposit, up to a maximum of a \$200 bonus for a \$1,000 initial deposit. Additional deposits may be made after the account has been established.
3. The customer must not have previously established a Book at Baldini's Mobile Sports account. Eligibility will be verified.
4. Once registered for a new account and an initial deposit is made, guest will receive a 20% bonus once the total initial deposit amount has been wagered through once.
5. The bonus will be added to the account within thirty (30) days of the total initial deposit amount being wagered once.
6. Must be 21 or older to be eligible.
7. The deposit amount must be wagered within 90 days of opening the account. If the entire deposit amount is not wagered before 90 days, the entire bonus expires.
8. Participation is void where prohibited or restricted by law.
9. This Promotion is subject to all applicable federal, state, and local laws and regulations, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities.
10. Guests agree to allow Baldini's Casino the unconditional use of their name and likeness for Promotions/advertising and announcements without compensation, consideration, notice, review, or consent.
11. Guests are responsible for payment of any and all taxes, licenses, registrations and other fees, as applicable.
12. Baldini's Casino reserves the right to make changes to or cancel the promotion at any time. Other restrictions may apply.

14. Baldini's Casino reserves the right to modify or cancel this Promotion at any time, for any reason, subject to any applicable regulatory approval, provided
